I am writing this column on December 12th. By the time you read this you will have already received a letter from the Mayor outlining one of the most important initiatives our Village has considered in the last 15 years, the opportunity for our community to remake US 1. Until the late 1980's, the Village of Tequesta and The Town of Jupiter

were small communities and I-95 through the Treasure Coast was an unrealized plan. By 1990, I-95 was complete providing residents, visitors and commuters with a fast North-South travel route and an alternative to US 1.

The process of gathering resident input, analyzing various scenarios and developing a proposal for submission to Florida's Department of Transportation (FDOT) will be done in partnership with Palm Beach County, Treasure Coast Regional Planning Council and the Town of Jupiter. The inputs, work products and deliverables will consist of the following:

- 1. The selection by the Village of a "Project Host Committee" to assist in the identification of key issues and logistics.
- 2. Interviews with local residents, businesses, property owners and relevant public agency staff to identify key issues and concerns.
- 3. A public workshop to garner public input regarding issues, concerns, opportunities and desired physical improvements.
- 4. Provide a fully detailed, fully illustrated, scaled master plan for the US 1- corridor addressing street design options, including, travel and turn lane configurations, bicycle routes, sidewalk, lighting and landscape improvements.
- 5. Methods and opportunities to improve multi-modal connections between US 1 and the adjoining properties and neighborhoods.

The goal is to improve the ambiance and function of US 1 so it best reflects and serves the residents of Tequesta and is consistent with the character of the Village. For this endeavor to succeed and deliver the results that reflect the interests of our community, we are asking you to take the time to provide us with your input be it through the scheduled events or directly to council members or Village staff.

In closing, I would like to leave you with a couple of thoughts. The first is a quote from Leonardo da Vinci. "I have been impressed with the urgency of doing. Knowing is not enough; we must apply. Being willing is not enough; we must do."

The second is from the invocation at our December council meeting. "Help us to keep our eyes constantly open to the serious issues that our Village government can and should solve or improve. To look forward to what all of us can accomplish by applying our collective talents and experience to the challenges that confront us. As we work together on behalf of all who live in this Village, may we gain strength and sustenance from one another through reason and compassion."

The Council looks forward to hearing from you on this important initiative. On a personal note, thank you all for granting me the privilege of representing and working for you.

An update from Mayor Abby Brennan

So now we wait.....

The Federal Railway Administration's (FRA) deadline for responses to the Draft Environmental Impact Statement (DEIS) concerning All Aboard Florida expired last month. Many Village of Tequesta residents and business owners contributed to over 8,000 pieces of correspon-



dence received by the FRA. Several independent organizations produced detailed reports compiled by experts in the marine, legal, financial, economic and environmental fields that challenged nearly every assertion made in the DEIS.

Village Council has always maintained that the negative impacts to our community, on both land and on water, will not be limited to the passage of thirty-two All Aboard Florida passenger trains. What may turn out to be equally disruptive, and perhaps more dangerous, is the expected increase to the current sixteen freight trains a day to twenty-two or more. These trains are projected to be even longer in length and include double-stacked intermodal train cars. We all know that freight trains routinely take five minutes or more to clear a crossing...and that's when they're moving at all.



Many of us have first-hand knowledge of what happens when the train trestle bridge malfunctions and all three grade crossings at County Line Road, Tequesta Drive and Riverside Drive are blocked by just one freight train. Not to mention when freight train cars are being connected or disconnected at the CEMEX plant on Old Dixie Highway. We sit at the lowered gates on Tequesta Drive watching a locomotive creep in one direction, stop, and then move back even slower the other way. Frustrating at best!

All Aboard Florida claims its passenger trains will take less than a minute to clear a grade crossing. That claim is suspect considering the fact that trains must slow down well before crossing the Loxahatchee River bridge and when navigating the sharp curve just south of the CEMEX plant. They also state that the decrepit bridge will be "improved." Unfortunately, numerous requests for specifics to verify the "less than a minute" claim and the exact nature of the bridge repairs have been ignored.

All of this information, as well as data provided by other towns and cities along the coastal route between West Palm Beach and Cocoa, has been sent to the FRA. I've been told that the amount of time it will take them to read, categorize and evaluate these comments will be, at the very least, four to five months. That's good.

So now we wait....then round two!



Village of Tequesta's Citizen Access Portal "CAP"

The Village of Tequesta now provides the public with online access to building permits, building plan reviews, fire prevention permits, and development review applications. The online building permit application information is



available from the date of August 1, 2014 to present.

You must be a registered contractor in the Village of Tequesta to apply for a permit or schedule an inspection over the internet.

A limited type of building "trade" permit applications is accepted online. The list of available permit applications will be displayed after you log in and select "Apply for a Permit". Currently, Owner Builder, New Constructions, Interior Build Outs, Additions, and Cell Towers, must be submitted in person to the Building Department located at 345 Tequesta Drive, Tequesta FL 33469. To obtain a username and password and an online application manual, please call (561)768-0450.

Website hours are 6 a.m. to 10 p.m.

To Schedule an Inspection Online:

You must be a registered contractor using a valid username and password to schedule an inspection over the internet. Inspections can be scheduled daily from 6:00 a.m. to 10:00 p.m. using the online permitting system. This system not only allows you to schedule inspections, but view inspection results.

All inspection results will be updated by 4:00 p.m. Please do not call the office inquiring about results prior to that time.

Required Fire Inspections are indicated on your Fire Permit and must be scheduled by 4:30 p.m. prior to the requested inspection date. Fire inspections are performed by the Fire Inspector between the hours of 1:30 p.m. - 3:30 p.m. and are separate and apart from the Building Department

If you are not a contractor or do not wish to apply online, you may still obtain a permit by applying at the Building Department, located at Village Hall, 345 Tequesta Drive, Tequesta, FL. You may download and print applicable forms from our website under building department forms. To find out if you need a permit or if you may have other questions, call us (561) 768-0450.

Traffic Saturations

Over the past few months, the Tequesta Police Department has received complaints of drivers not following the rules of the road. Residents have complained of vehicles speeding, driving aggressively, failing to stop at stop signs and disregarding red lights. This can create stressful situations for drivers as well as being very dangerous. To address this problem, the Tequesta Police Department has partnered with Town of Jupiter, City of Palm Beach Gardens, Village of North Palm Beach



and Town of Juno Beach to create traffic enforcement events to address these problems.

These events are referred to as "Traffic Saturations," whereby through a mutual aid agreement between the municipalities and Palm Beach County, officers can enforce laws in another's jurisdiction. In basic terms, a Juno Beach police officer can conduct a traffic stop in a participating municipality (for example, Tequesta) during the event. Even though we are capable of handling our own traffic enforcement initiatives we have been conducting these traffic saturations regularly as well. This allows us to bring in extra police officers from neighboring jurisdictions to enforce more areas within the Village to address pressing issues.

The Tequesta Police Department takes aggressive driving seriously and actively encourages safe driving. We would like to remind you what to do in case you are pulled over by a police

- When you see the overhead lights and/or hear the siren, remain calm and safely pull over parallel to the right side of the road when it is safe to do so.
- Remain in your vehicle unless the officer advises otherwise.
- Keep your hands on the steering wheel so the officer can see them.
- Avoid any sudden movements, especially toward the floorboard, rear seat or passenger side of the vehicle.
- Do not immediately reach for your license or other documents until the officer requests them. Florida Law requires drivers to show their license, registration and insurance card
- If your documents are out of reach, tell the officer where they are before you reach for them.
- If the stop occurs during darkness, put on your dome or interior lights so the officer can easily see that all is in order.
- If there are passengers in your vehicle, encourage them to remain quiet and cooperate with instructions. You, as the operator, are solely responsible for your vehicle and its occupants.
- The officer may issue you a ticket. Avoid becoming argumentative. Arguing will not change the officer's mind. If you contest the violation, you will have an opportunity to
- 10. Be honest with the officer. If you really didn't see the stop sign, or were unaware of the speed limit, let the officer know. Being honest about any situation never hurts. Officers do issue warnings.
- 11. It is normal, from time to time, to see two or three other police officers on a routine traffic stop. This is for the safety of everyone involved since we often do not know who we are stopping.
- 12. If you receive a ticket, accept it calmly. Again, if you disagree with it, you have the right to contest it in court.
- 13. Lastly, if you feel your traffic stop experience was not handled in a respectful and professional manner, then we would like to hear about it. We have forms on the Village website where you can compliment an officer as well as make a complaint or suggestion. As with any service organization we always welcome feedback.

The Fire Department's Mission Statement begins with the words, "The primary function of Tequesta Fire-Rescue is to prevent and mitigate..." It is our responsibility to care for the sick and injured but it is our mission to prevent and mitigate these injuries whenever possible. To this end the Fire-Rescue department provides a variety of services to our residents. The following are two of those services.

Blood Pressure Screenings

The American Heart Association estimates that one in three adults in the United States is affected by High Blood Pressure, or Hypertension. Hypertension is a medical condition characterized by chronically elevated blood pressure. An elevation of the blood pressure increases the risk of developing heart disease, kidney disease, hardening of the arteries, eye damage, and stroke. Tequesta Fire-Rescue offers free blood pressure screenings to anyone who stops into the Fire Station. No appointment is necessary. Your physician may desire a number of blood pressure tests to determine whether you are chronically elevated and Tequesta Fire-Rescue is happy to assist you with these tests. If you experience any symptoms such as severe headache, blurred vision, ringing in the ears, weakness or dizziness, chest pain or difficulty breathing immediately call 911 and we will come to you. However, for routine checks please stop in and let Tequesta Fire-Rescue assist you.

CPR Training

Would you be surprised to learn that bystander CPR is done in less than half of all out-of-hospital cardiac arrests? National statistics have shown that only 15 to 30 percent of people who experience sudden cardiac arrests outside of hospitals receive bystander CPR. When people are asked why they would not give CPR, a very common answer is that they never received training. Tequesta Fire-Rescue provides CPR Training to our residents on the 2nd Saturday of every month at 10am in the Fire Station. The cost is \$25 for residents and \$35 for non-residents. Call the station at 561-768-0550 to sign up. Please come by and take advantage of this opportunity. You may save the life of someone who is very dear to you!

Registered voters of Precincts 1078, 1088, 1094, 1112, 1116, 1118 and 1120 are qualified to vote in this election. To qualify as a registered voter for the Municipal Election, you must register with the Palm Beach County Supervisor of Elections by Monday, February 9, 2015.

The candidate for each Seat receiving the highest number of votes cast for such office shall be deemed elected to such office regardless of whether or not such candidate shall have received a majority of votes cast. In the event of a tie vote between the candidates receiving the highest number of votes cast for any office, the names of all tied candidates shall be placed on the ballot and shall be voted upon at an ensuing runoff election to be held on March 24, 2015. Such election shall be held in the same manner and by the same election officials holding the previous election.



Historical Archives




For some time the Village Clerk's office has been cataloging historical data and donations provided by residents. Our archives contain interesting items,

Four years ago, the Tequesta Fire-Rescue Firefighters teamed up with the Tequesta Brewing Company, a local craft brewery, to raise money for Honor Flight. Honor Flight is a national organization that takes WWII Veterans to Washington DC to see the WWII Memorial, Arlington National Cemetery and other related sites. Firefighters and the Military have always shared a common bond of service in the face of danger, but the events of 9-11 have brought us closer together than ever, and the Tequesta Firefighters wished to show their respect and to honor those who have fought for our freedoms.
