- 4) If the owner of the above-described property should lease this property, we will require lessee to make their contractual arrangements for water service. The security deposit paid by the property owner shall be retained by the Water Department as additional security for service to this property. All unsatisfied water service debt becomes the responsibility of the property owner.

By application, customer recognizes that Tequesta Water Department is not responsible for loss or damage to customer's property as a result of the initiation of water service.
